NOC to Bharat School of Nursing to run ANM course from academic year 2019-20 Onwands.

Kindly refer to the subject noted above.

In continuation of Govt. letter of even number dated 09.08.2018, Government has decided to issue 'No Objection Certificate/Essentiality Certificate' for ANM for 30 seats in Bharat School of Nursing, Ladwa, Shahabad Road, Distt. Kurukshetra. The following conditions are to be followed:-

 The admission will be made on the enhanced seats as approved by the State Government from the academic year 2019-20 onwards.

- 2. The Institution shall at its own level seek affiliation from the Haryana Nurses and Nurse Midwives Council (HN&NMC). Inspection by HN&NMC for granting affiliation for the purpose of admission in current academic session 2019-20 is not required and affiliation certificate may be issued by HN&NMC on the basis of State NOC and admission be made on the basis of State NOC. However, from subsequent years, HN&NMC may conduct the inspection for affiliation as per the procedure followed. The College authorities should deposit requisite fee and fulfill all other requirements for affiliation.
- A copy of affiliation and approvals so received shall be submitted to the Director, Medical Education & Research Department, Haryana.
- 4. No financial assistance/grant of any kind in any form will be given by the State Government to run these courses/Institute to the Trust. The Institute shall have to bear all the recurring and non-recurring expenditure for all time to come from its own resources.
- The State Government will not give any grant for building etc. at any time. The building intended for educational occupancy will not be used for any hazardous occupation.
- 6. The State Government will not take over the school at the request of the Institution.
- All the conditions of affiliation prescribed by Haryana Nurses and Nurse Midwives
 Council will have to be met with by the applicant Trust.
 The Trust.
- The Trust will recruit the staff as per Government, Indian Nursing Council and Haryana Nurses and Nurse Midwives Council guidelines and pay the salary to the staff directly in their Aadhar linked Bank Accounts.
- The Trust will give an affidavit to the effect that Institute will create provident fund for the welfare of employees.
- 10. Before admitting the students, the applicant Trust/college authorities will deposit an amount of Rs.20.00 lacs for diploma courses and Rs. 30.00 lacs for degree courses in the shape of FDRs initially fixed for five years in the name "Member Secretary, Haryana State Medical Education Society" payable at Panchkula. The FDR will be handed over in original to the DMER Haryana.

- 11. The FDRs shall be renewed at the time of renewal of the NOC or well before the expiry date, whichever is earlier.
- 12. In case the Institute is not found able to run itself, the NOC will be withdrawn after providing an opportunity of hearing to it and the FDRs submitted by the Trust shall be forfeited and utilized for continuing the studies of the enrolled students/payment of salary of the staff and other costs of running the Institute till the completion of ongoing session. In case the funds available in the Institute are not sufficient, the balance amount shall be recovered from the Trust and its Promoters as per law including through arrears of land revenue.

13. Tuition fee and other charges including Hostel charges to be taken from the student will be as per the norms and as fixed by State Government Fee fixation Committee as per provisions of the Haryana Private Health Sciences Educational Institution Act, 2012.

- 14. The Trust will not sub-let/lease out the Institute and will use the NOC for establishing Nursing Practitioner Course in Critical Care Course at the place other than the one mentioned in the application form for the NOC.
- 15. The Institute has to comply with the provisions of Haryana Private Health Sciences Educational Institution Act, 2012.
- 16. The Government may impose any other reasonable conditions in public interest at any time, which shall be binding on the Institute/Trust.
- 17. The Institute will be inspected through the inspection Committee, Haryana Nurses and Nurse Midwives Council or Department of Medical Education and Research, Haryana at any time without any notice.
- 18. The Institute would take all steps to ensure that no incidence of ragging occurs in the College and abide by all the instructions about ragging issued by the Government of India, State Government and Hon'ble Courts from time to time.
- 19. The Building intended for Nursing Education will not be used for any other purpose.
- 20. The State Government has right to withdraw the NOC without any notice in case of any adverse report about the College/Trust and its Promoters or in case any of the papers submitted by it are found to be false.
- 21. Any contravention of the above stated conditions shall result in withdrawal of the NOC and legal action against the defaulting Trust, Institute and/or its Promoters would also be initiated.
